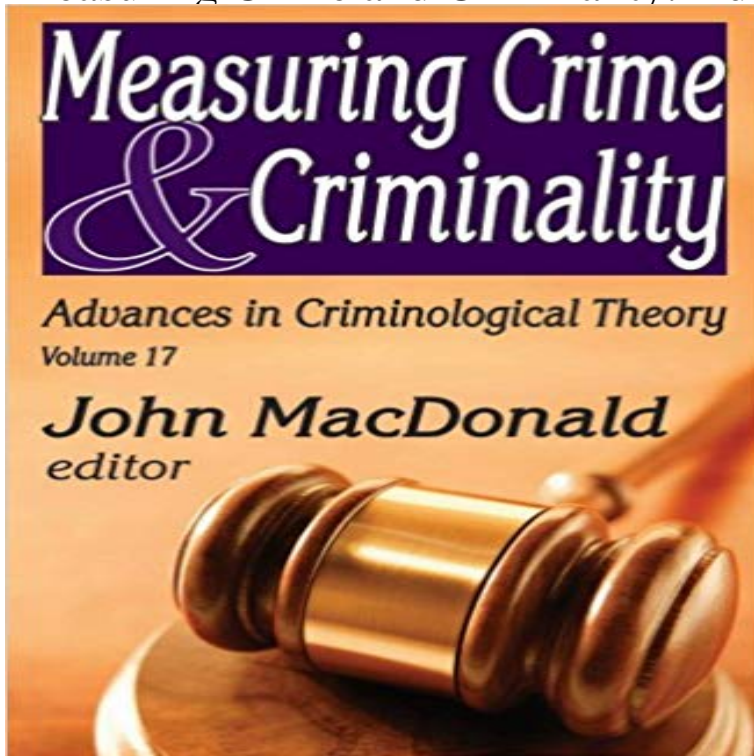


Measuring Crime and Criminality: Advances in Criminological Theory
