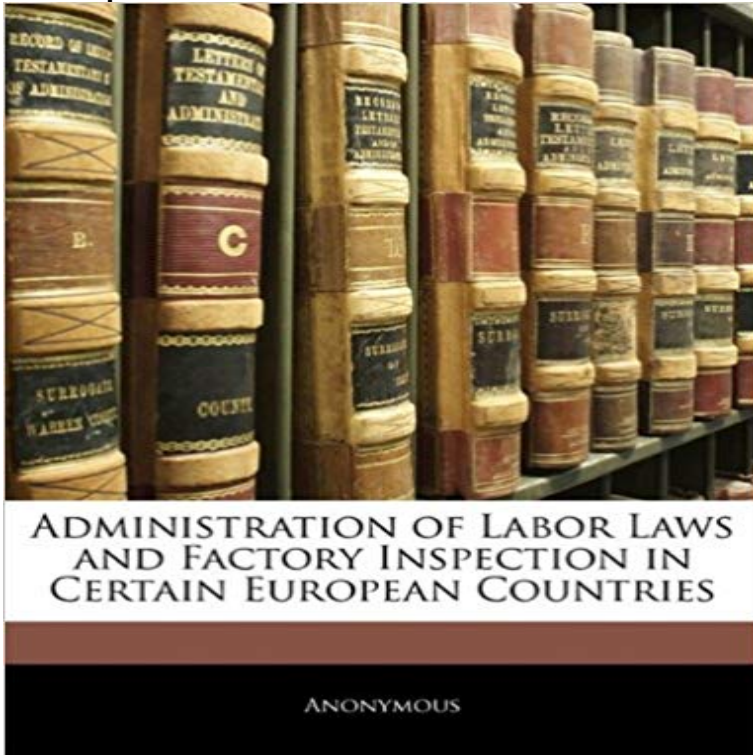


# Administration of Labor Laws and Factory Inspection in Certain European Countries
