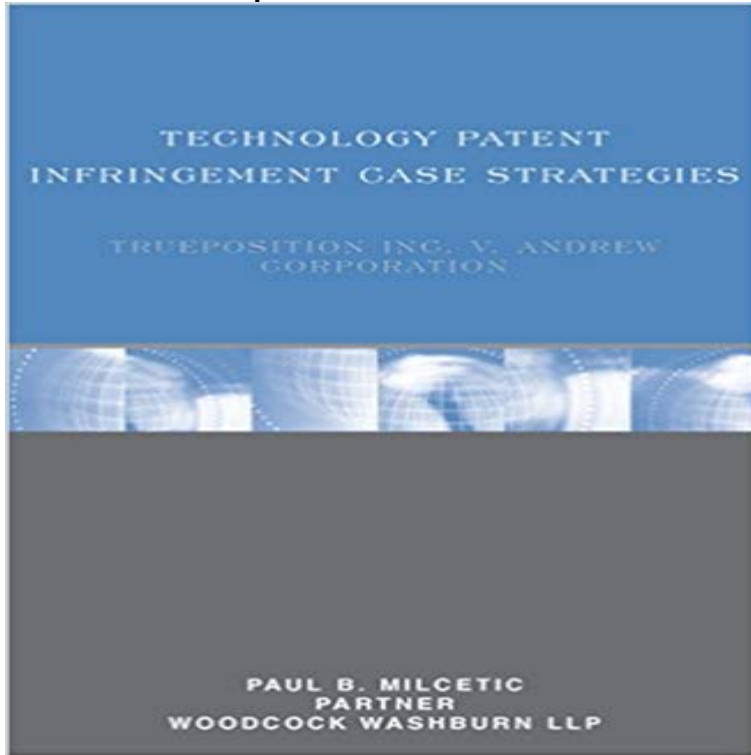


# Technology Patent Infringement Case Strategies: TruePosition Inc. v. Andrew Corporation
