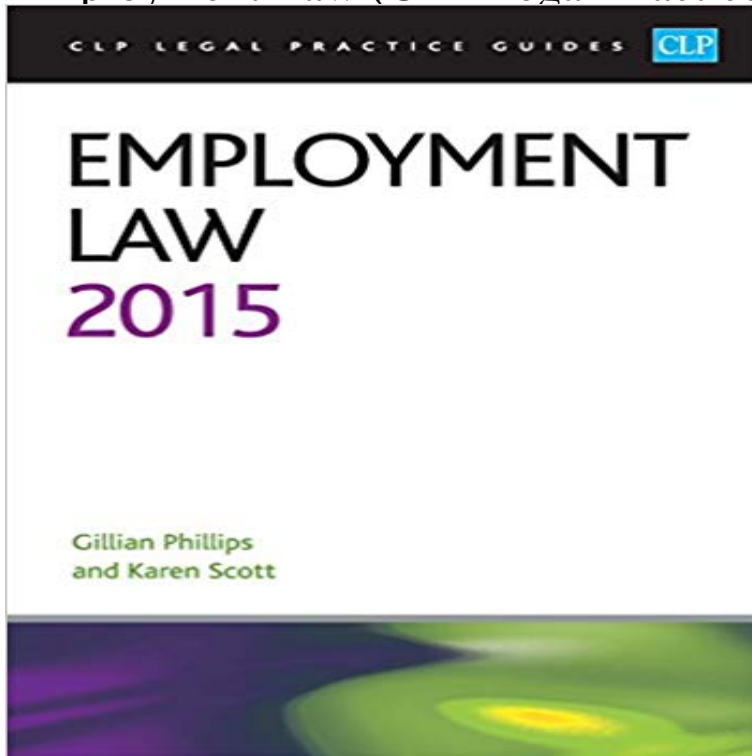


Employment Law (CLP Legal Practice Guides)
