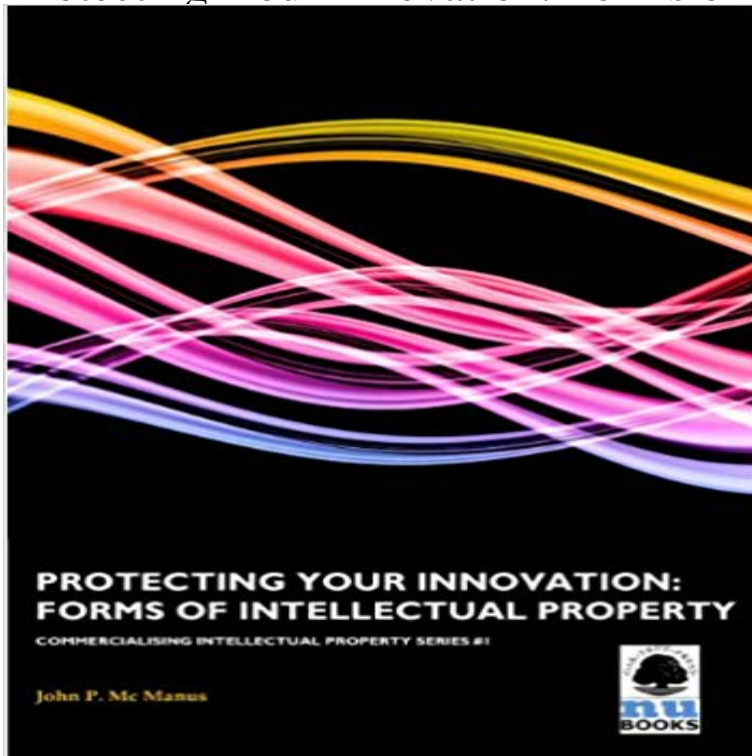


## Protecting Your Innovation: Forms of Intellectual Property (1)
