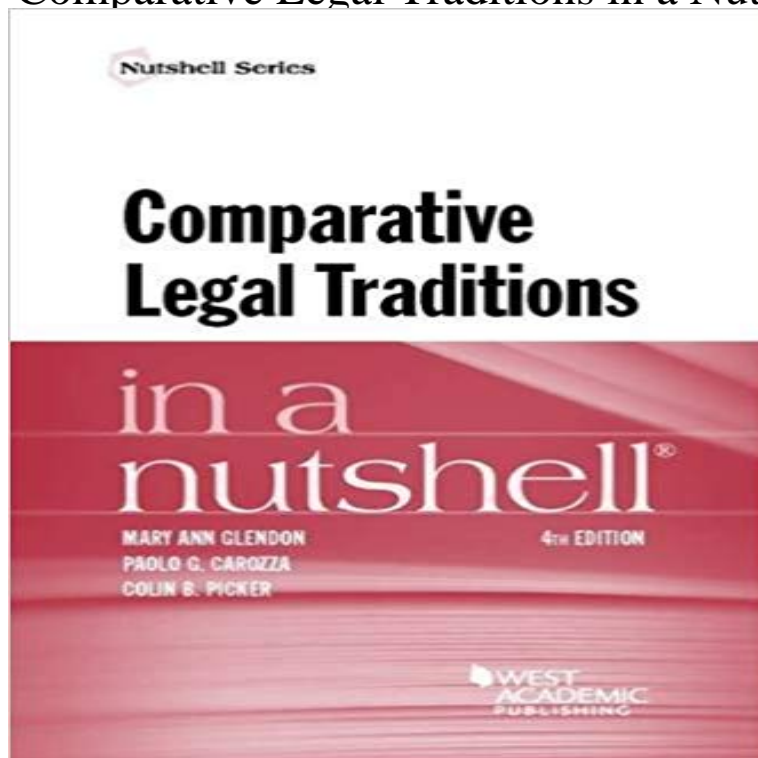


Comparative Legal Traditions in a Nutshell
