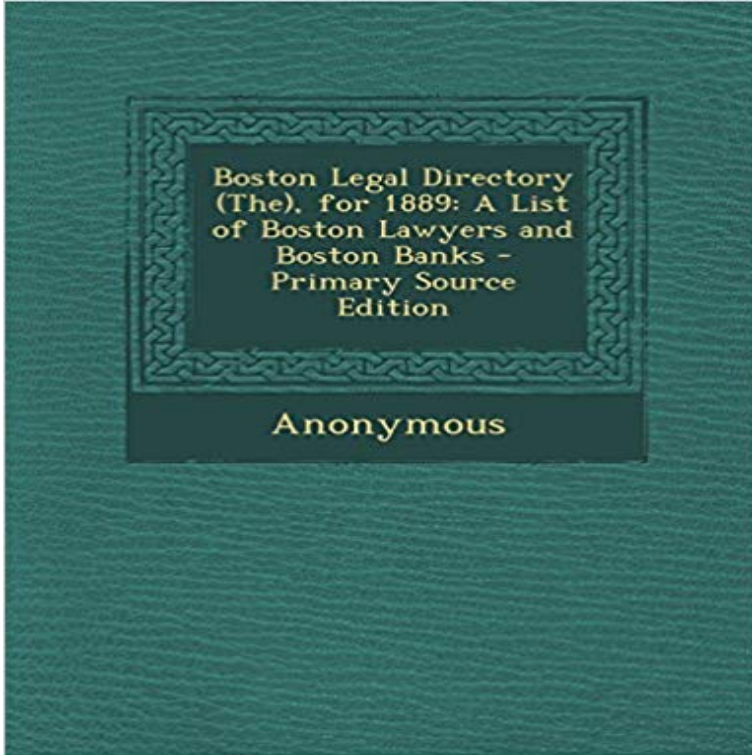


Boston Legal Directory (The), for 1889: A List of Boston Lawyers and Boston Banks - Primary Source Edition
