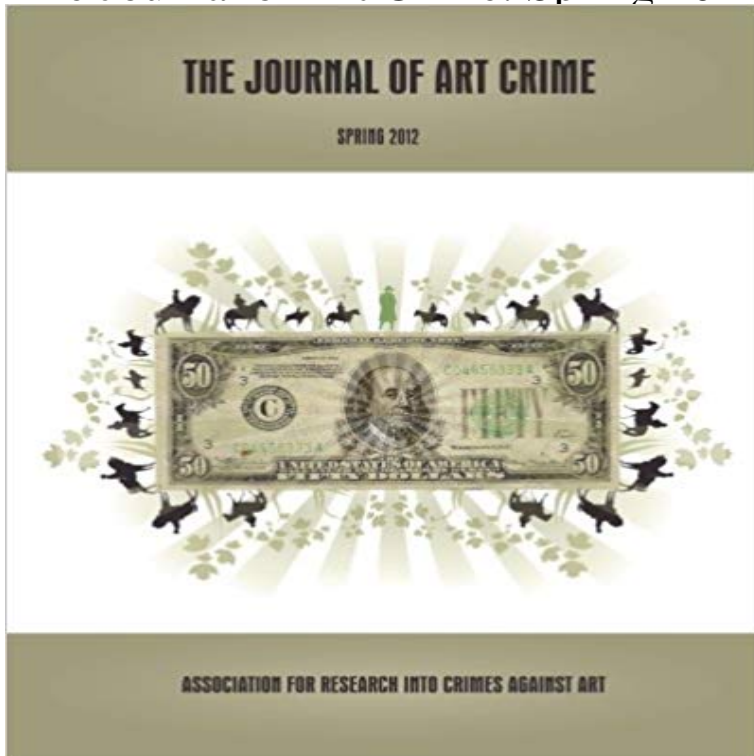


## The Journal of Art Crime: Spring 2012 (Volume 7)
