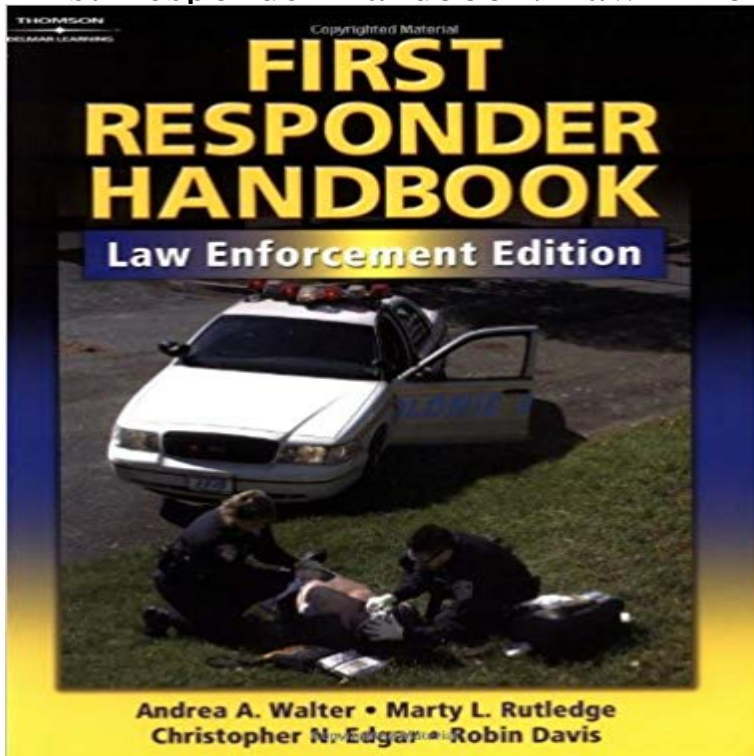


# First Responder Handbook: Law Enforcement Edition
