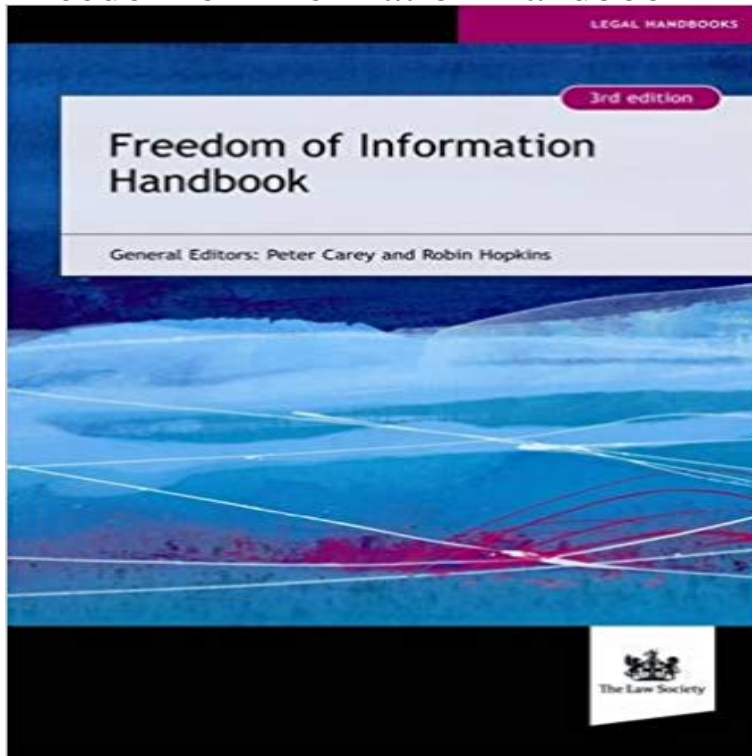


Freedom of Information Handbook



The introduction of the Freedom of Information Act 2000 (FOIA) revolutionised the public's access to public authority information, notably through decisions made by the Information Commissioner, Information Tribunal and courts. FOIA was amended by the Protection of Freedoms Act 2012. The third edition of this practical and authoritative handbook assimilates these changes and others. Comprehensively revised, it covers in detail: changes to the law on the disclosure of datasets by public authorities; the extension of FOIA to cover companies owned by more than one public authority; changes to the role of Information Commissioner; recent decisions of the Information Commissioner and Information Tribunal.
