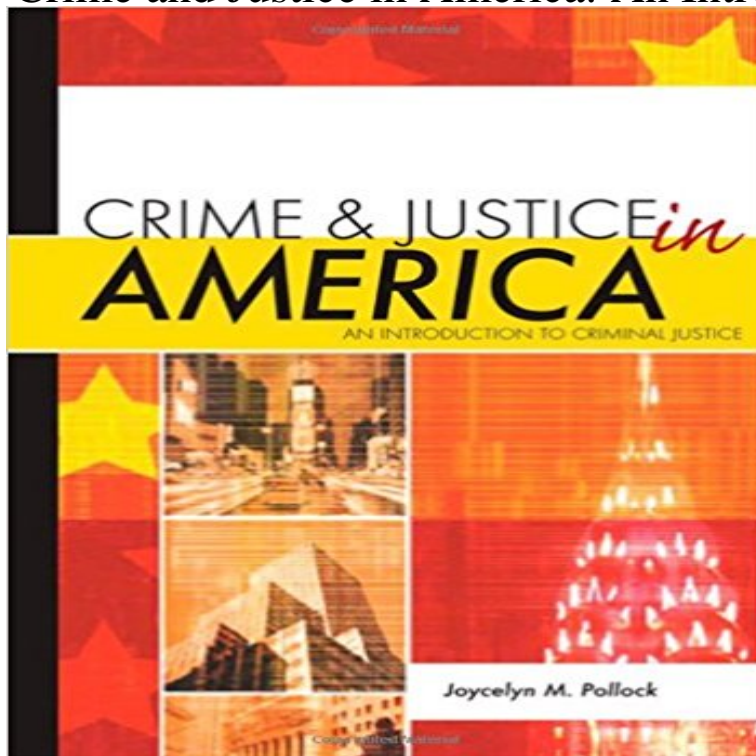


Crime and Justice in America: An Introduction to Criminal Justice
