

## Preserving Prior User Rights-a Valuable Shield Against Patent Trolls & Others



Authored by Edward Marquette, Partner at Kutak Rock, LLP. Executives do not simply have to wait to be the next victim of a patent troll. A company can be proactive in taking steps to erect a barrier against attack with respect to its mission critical processes, and products. Moreover, the strategy does not require huge expenditures or the build-up of a massive portfolio of patents. Instead, smart companies prepare by stepping back, assessing the landscape of exposure, and by adopting a comprehensive intellectual property strategy that includes effective exercise of prior user rights (PUR). Virtually unnoticed by the media, and the patent bar, Congress, with the America Invents Act (the AIA), issued, in the fall of 2011, veritable template instructions for building very strong shields to patent exposure, not only from patent trolls, but also from competitors. The benefits of PUR have gone largely unnoticed by what may be described as the silo mentality of the bar. The patent bar does not find PUR particularly interesting probably because it doesn't drive revenue. There are no patents to file and prosecute under PUR; it stops patent litigation instead of fueling it. Corporate counsel, which should be looking at overall legal strategy for a company, may be aware of patents, patent trolls, and patent litigation, but unless extraordinarily well informed, they have no idea what prior user rights are.
