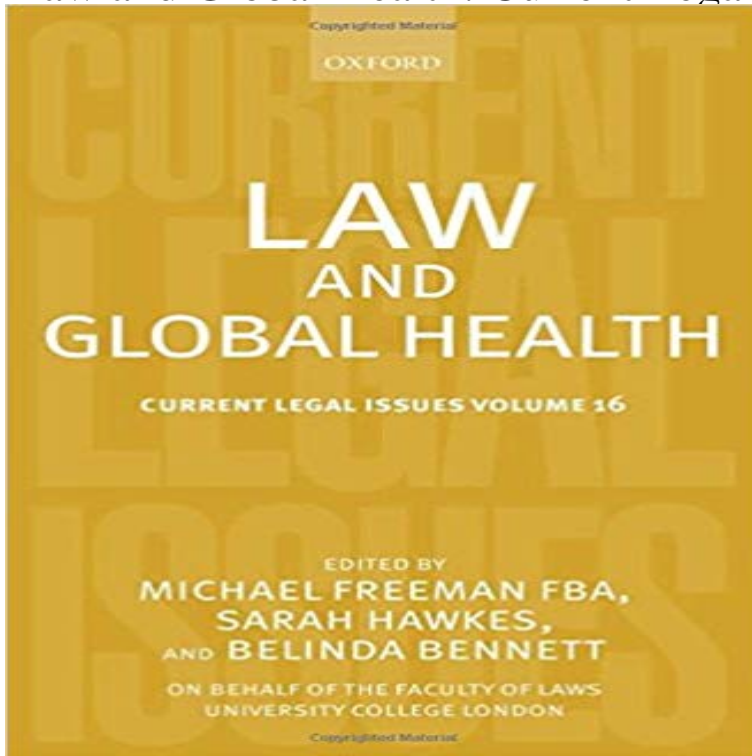


Law and Global Health: Current Legal Issues Volume 16
