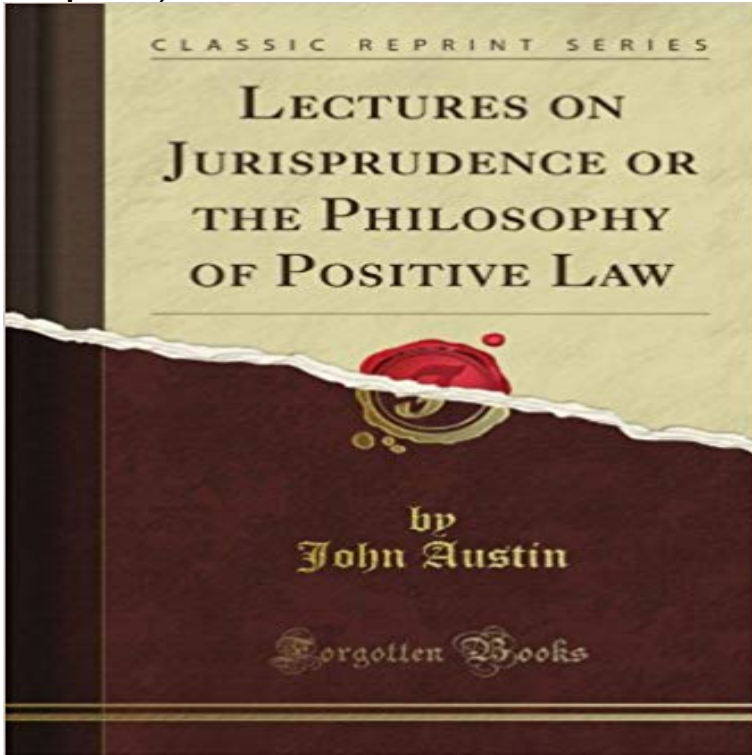


## Lectures on Jurisprudence or the Philosophy of Positive Law (Classic Reprint)



John Austin's work in the field of jurisprudence has been now so long and so widely recognized that it would be superfluous to insist upon them in this place. Except by a very few persons, the recognition was late. Had it come earlier, the author might have been encouraged to complete the record of the work upon which he entered. As it is, that record breaks off in medio; and for the preservation and arrangement of what remains, the public are in great measure indebted to the ability and industry of the lady whose name is subscribed to the preface of the first posthumous edition. In that preface Mrs. Austin explained, by a personal narrative of consummate literary skill and absorbing interest, the reasons why the work was broken off and never resumed by its author. An attempt to abridge that narrative would be almost an injury to both the persons here referred to.
