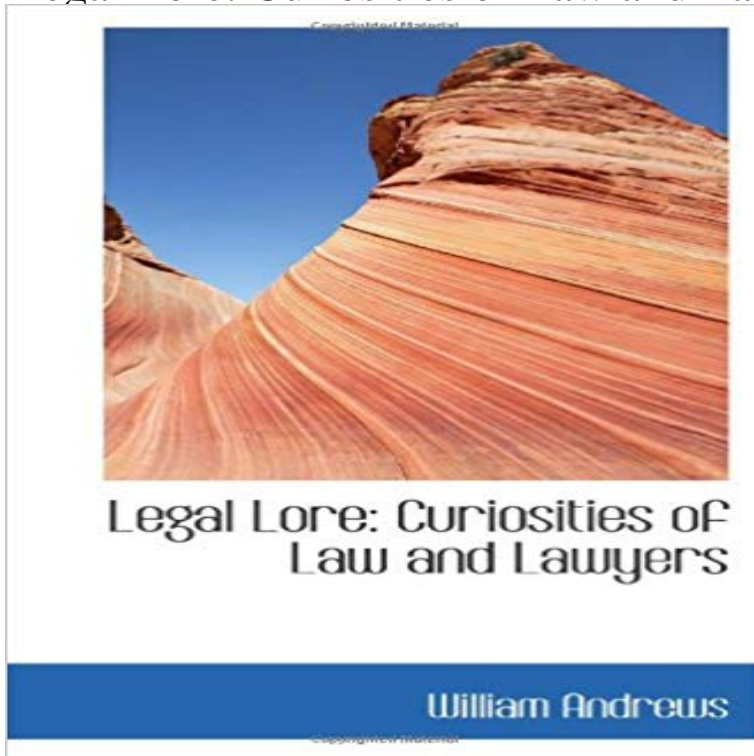


Legal Lore: Curiosities of Law and Lawyers
