


# Enforcing Your Companys IP Rights: Temporary Restraining Orders and Preliminary Injunctions

This chapter will focus on the factors that go into the decision to seek early injunctive relief against acts of infringement in the context of intellectual property infringement litigation. Such early injunctive relief may take the form of a temporary restraining order or a preliminary injunction. A temporary restraining order can provide almost immediate injunctive relief typically within 24-48 hours. A preliminary injunction can provide injunctive relief against further harm after a regular notice period, for example 21 to 28 days or more.

The following will consider only Federal law and procedure. It is often a difficult question for anyone, whether an individual or a corporation, to decide how aggressively to pursue enforcement of ones intellectual property rights. Several factors to consider include the strength of the intellectual property rights being asserted, the degree to which the defendant is infringing, and what it may cost to get a favorable result. While those questions usually cannot be answered with much certainty at the outset, there are certain steps that can be taken early in the process to give one a better idea. One such step is the consideration of whether early injunctive relief to prevent the defendant from continuing the infringing acts, by way of a temporary restraining order or a preliminary injunction. The detailed analysis related to such a request for relief pulls together most of the facts critical to the claim and compiles the current, relevant law from your jurisdiction. When deciding between a temporary restraining order and a preliminary injunction, one must determine whether there are specific facts to demonstrate immediate and irreparable injury, loss, or damage to the applicant in the absence of a temporary restraining order. Although the standard

varies from court to court, injunctive relief, by either method, typically requires proof of either: (1) the existence of serious questions going to the merits of the claims and the balance of hardships tipping in the moving partys favor; or (2) a combination of probable success on the merits of the claims and the possibility of irreparable injury to the moving party in the absence of injunctive relief. A number of benefits can be realized from preparing the application or motion for injunctive relief. The investigation and analysis can give an infringement claimant a better idea of the strengths and weaknesses of its claims. Similarly, it can educate the infringement defendant about the claim and send a strong message. In addition, the infringement defendants response/opposition will likely reveal its strategy to defend against the infringement claim. Finally, the application or motion can provide an early education to the court about the facts of the case and a ruling may provide insight as to how the claim may be ultimately resolved. Temporary restraining orders and/or preliminary injunctions are provisional remedies. They are only entered to prevent irreparable injury prior to the final disposition. Another way of looking at an injunction is that it preserves the status quo during pendency of the litigation. As will be discussed more fully below, if the party seeking injunctive relief cannot establish irreparable injury then the court will likely not grant the relief sought. Irreparable injury usually refers to injury that cannot be remedied through other means, such as monetary compensation.
