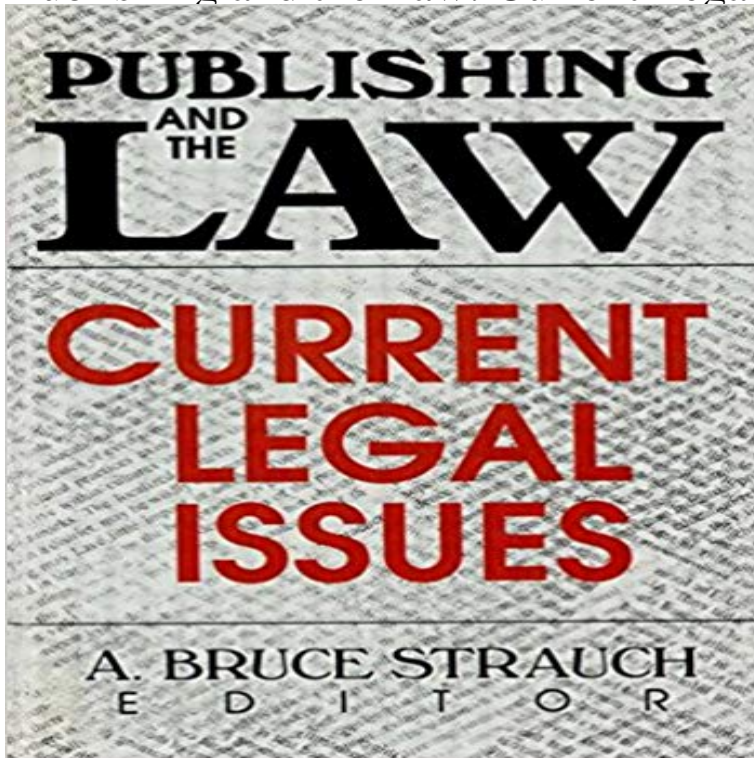


Publishing and the Law: Current Legal Issues

In an age of advancing technology, Congress and the courts will be called upon with more and more frequency to maintain a balance between
