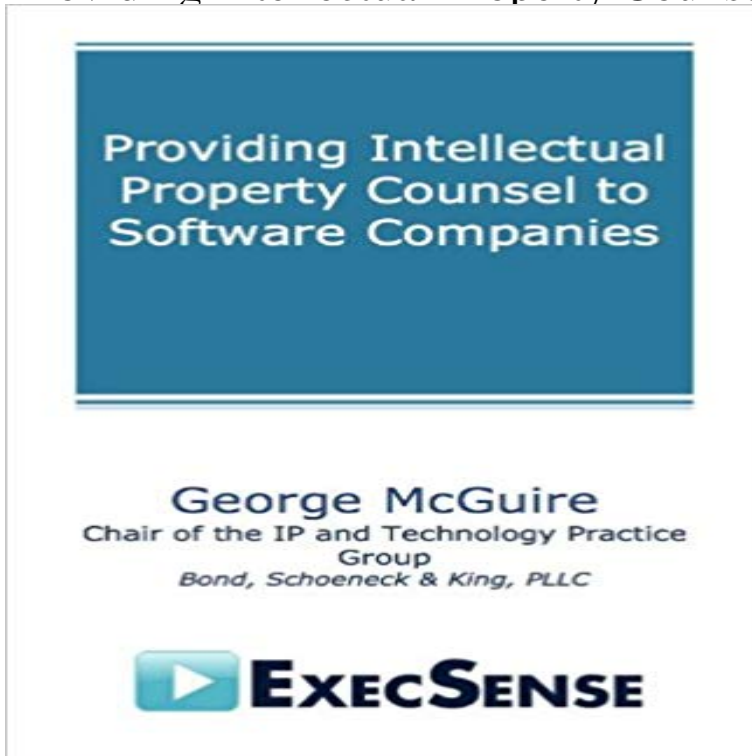


Providing Intellectual Property Counsel to Software Companies
