

The Role of the Patent System in Stimulating Innovation and Technology Transfer for Climate Change: Including Aspects of Licensing and Competition Law (Munich Intellectual Property Law Center - MIPLC)



The world increasingly faces the adverse impact of climate change. What role can intellectual property play to stimulate the necessary innovation and technology transfer? Providing an inventory of patent law, policy, and information, including certain private initiatives, this LL.M. thesis discusses issues at the crossroads of intellectual property and climate change, such as: compulsory licensing for climate change * patent offices preferential treatment policy for green technology and TRIPS (Trade-Related Aspects of Intellectual Property Rights) compliance * consideration of greenness in substantive patent law * antitrust disputes affecting green technology sectors. Just as technical progress on climate change is rooted in an open range of scientific experimentation, intellectual property must offer complementary solutions. Whether through public or private initiative, key among these, the thesis concludes, is the optimal provision of information to technology users. LL.M. Thesis.
