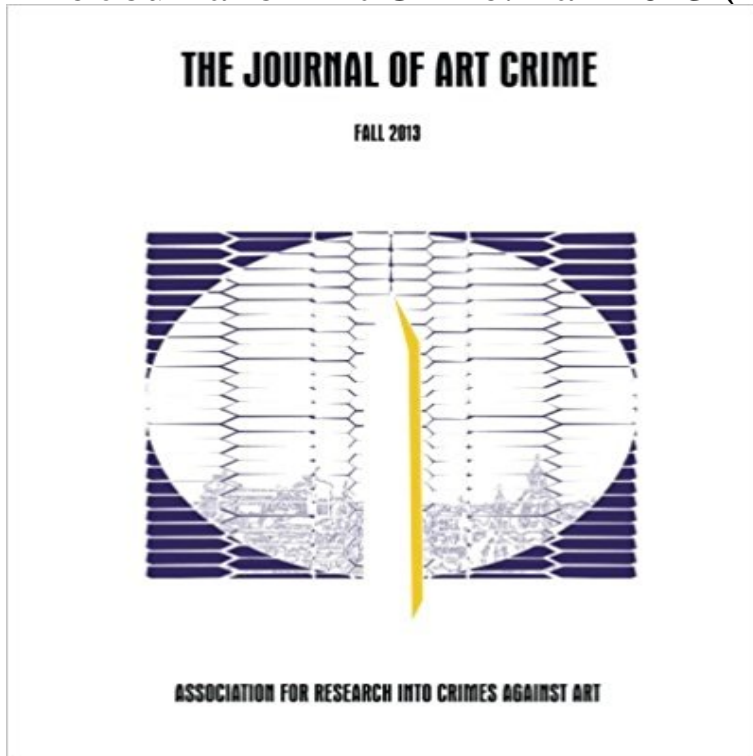


## The Journal of Art Crime: Fall 2013 (Volume 10)
