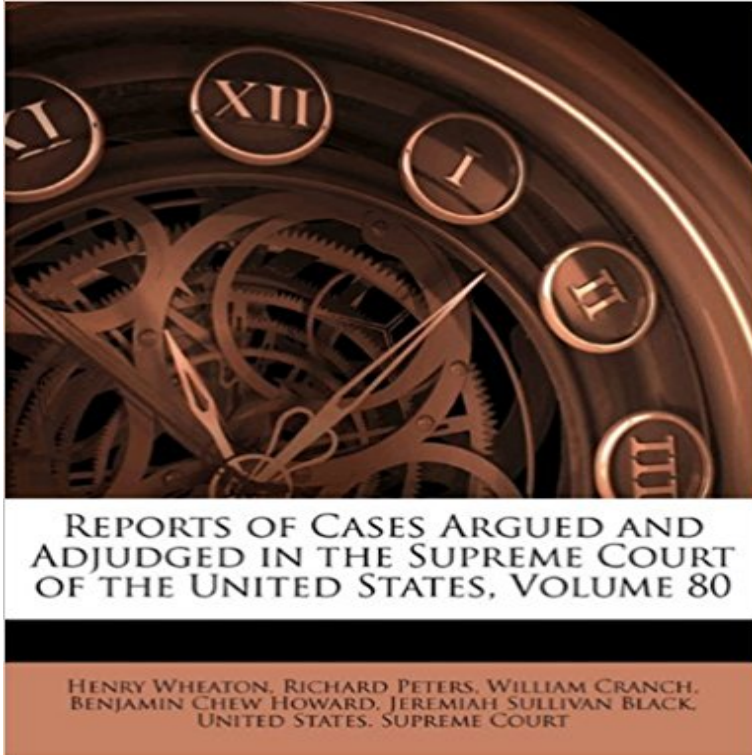


# Reports of Cases Argued and Adjudged in the Supreme Court of the United States, Volume 80
