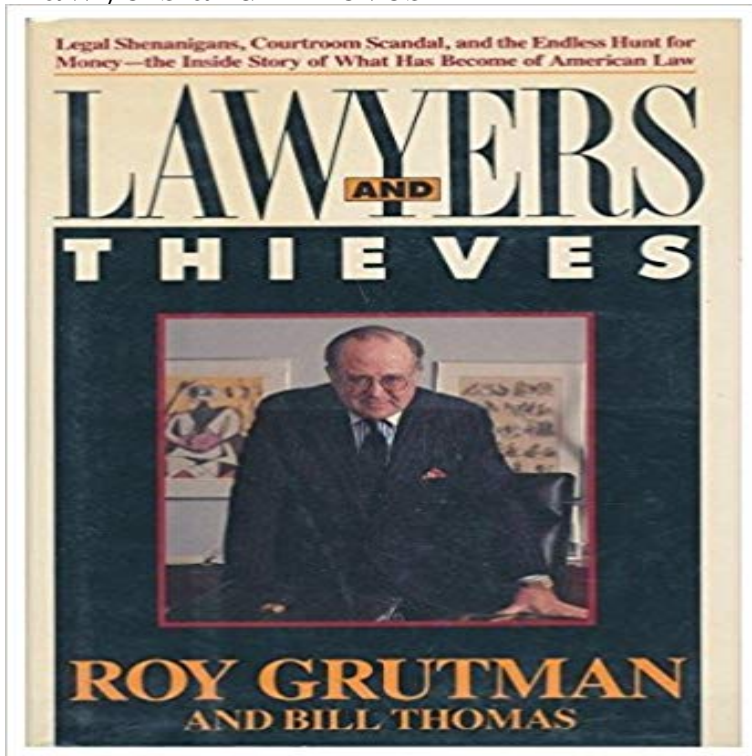


## Lawyers and Thieves



Written by one of Americas trial lawyers, this book examines legal shenanigans, courtroom scandal and the endless hunt for money. The author gives a behind-the-scenes tour of American law - and a scathing indictment of its frequent excesses. Using some of his own cases as examples, he examines every facet of todays legal trench warfare, including libel (mudslinging), personal injury (crying wolf) and malpractice. Along the way, he traces the explosive growth of legal greed, from sporadic ambulance chasing in the 1950s to todays sophisticated and relentless search for collectible clients.
